THE ACTION PLAN FOR ROMA INTEGRATION INTO THE LITHUANIAN SOCIETY FOR 2012-2014

1. The Action Plan for Roma Integration into the Lithuanian Society for 2012-2014 (hereinafter:

the Action Plan) is aimed at promoting participation of Roma in public life, reducing social

exclusion, enhancing conciousness within the Roma community as well as increasing public

tolerance.

2. This Action Plan was devised with a view to implementing the European Commission's

Communication on an EU Framework for National Roma Integration Strategies up to 2020 of

5 April 2011, with due regards to the recommendations of the European Commission against

Racism and Intolerance (ECRI) of 22 June 2011 and the recommendations of the Advisory

Committee on the Council of Europe Framework Convention for the Protection of National

Minorities of 28 February 2008, as well as on the basis of a sociological survey "Roma

Situation: Roma at the Cross-Road of Education and Labour market" (hereinafter: sociological

survey).

3. The Action Plan establishes the following goals:

3.1. to improve the social status of Roma;

3.2. to create conditions for intercultural dialogue.

4. The Action Plan will focus its major attention on the following four areas:

4.1. Education of Roma

The Ministry of Culture collected data, which reveal that during the current decade the number

of Roma schoolchildren at comprehensive schools has increased from 276 schoolchildren in the

academic year 1996-1997 to 572 schoolchildren in the academic year 2011-2012, respectively.

However, the majority of Roma schoolchildren acquire primary education and overcome only few

steps of the basic education level. The results of the sociological survey illustrate that a part of

Roma studying at 5th–7th grades has relatively increased. On average, Roma studied at schools from 6 to 7 years and, generally, finished 5 grades. One-fourth of Roma respondents attended only primary school and had finished 1st–4th grades. The major part of Roma did not acquire basic or secondary education. One-third of all Roma surveyed attended a comprehensive school, however, they did not finish more than 8 grades, i.e. did not overcome the basic education level. Only 17.3 percent of Roma surveyed finished 9 or more grades of comprehensive education.

4.2. Participation of Roma in the labour market

The lack of relevant education and qualifications restrict the opportunities of Roma to find a job. Based on the results of the sociological survey, 56.7 percent of adult Roma were unemployed. 40.7 percent of the surveyed indicated that at that time they had a job or occupation (in most cases, these were informal individual activities, such as collection of scrap metal, fortune-telling and trading in the market). Only 8,7 percent of Roma surveyed were employed under the labour contracts, whereas 6.1 percent of the surveyed worked without a labour contract. Social benefits comprised the main source of income for more than one-third of Roma. The majority of Roma surveyed (83.2 percent) indicated having no professional qualification. 16 percent of the respondents pointed out having gained the florist's, tailor's, driver's, mechanics', carpenter's, seller assistant's, musician's speciality.

4.3. Development of Roma social skills

Due to unfavourable living conditions and insufficient education the representatives of Roma lack social skills and human resources in organising their community effectively. Pursuant to the results of the sociological survey, Roma, to a certain extent, narrow their relations within their community and, in principal, apply to health care institutions, educational establishements and institutions of social support. It is significant to note, that 27.5 percent of Roma surveyed, who had school-age children, pointed out that during the last 12 month they neither applied to school institutions nor had any contacts there. For the most part, these were Roma women of different age and unemployed, who addressed to social workers.

4.4. Promotion of public tolerance with regard to Roma

Representatives of Roma undergo discrimination in the labour market, educational system, in service sector and other domains. Following the results presented by the Office of Equal Opportunity Ombudsman, in year 2010 Roma complaints comprised 25 percent of all the complaints submitted to this institution based on nationality, race, ethnicity and national origin. In year 2011, there were no complaints submitted by Roma; whereas the Equal Opportunity Ombudsman iniciated one investigation ex officio concerning the case of disrimination of Roma.

The data provided by the Institute for Ethnic Studies at the Lithuanian Social Research Centre suggest that the number of people who would not want Roma in their neighbourhood has been constantly increasing: in year 1990 59 percent of the respondents supported such a view, in 1999 - 62 percent, in 2000 - 77 percent, whereas in 2009 57,8 percent of the respondents agreed with this argument and 64,6 percent in year 2011, respectively. One-third of the citizens of the Republic of Lithuania declares that over the past 5 years their opinion with regard to Roma has worsened considerably or has worsen rather than improved.

- 5. The Ministry of Culture of the Republic of Lithuania coordinates the implementation of measures set up in the Action Plan. An intergovernmental working group established under the order of the Minister of Culture conducts monitoring of the measures set up in the Action Plan.
- 6. The implementation of measures envisaged in the Action Plan will be financed from the general allocations of the State Budget of the Republic of Lithuania, the European Union Structural Funds and the European Commission Programme for Employment and Solidarity PROGRESS.
- 7. Upon expiry of the the validity period of the Action Plan in 2014, the Ministry of Culture will prepare a draft legal act, which will ensure continuity of measures promoting Roma integration into the Lithuanian society.
