# Words into Action to Address Anti-Semitism

- Addressing the security needs of Jewish communities;
- Countering anti-Semitism through education; and
- Fostering coalition building among different communities.

The OSCE Office for
Democratic Institutions
and Human Rights (ODIHR)
has developed the Words
Into Action to Address
Anti-Semitism project
to strengthen the capacity
of OSCE participating States
and civil society to prevent
and respond to anti-Semitism.

Starting in 2016 under the German OSCE Chairmanship, which has generously provided funding for the multi-year project, ODIHR will carry out activities in the three interconnected areas listed above.

From the 2004 Berlin Declaration onwards, OSCE participating States have made numerous commitments on preventing and responding to manifestations of anti-Semitism and other acts of intolerance, incitement, harassment or violence against persons or communities based on ethnic origin or religious belief. ODIHR will undertake extensive activities geared toward developing new channels of assistance for participating States and ways of encouraging governments to fulfil their commitments.

### Activities

Specifically, ODIHR will undertake activities in all three areas, including:

# Addressing the security needs of Jewish communities

Draft a security policy guidline document for governments through expert and stakeholder consultations, and begin work on a reporting app that makes it easier for civil society to document anti-Semitic incidents:

# Countering anti-Semitism through education

Develop education policy guidelines through expert and practitioner consultations, and a blueprint for multimedia tools that support new ideas for school curricula, as well as funding a range of short projects; and



"OSCE participating States have recognized that anti-Semitism poses a threat to stability and security in the OSCE region. They agreed to undertake a number of steps to address the problem in co-operation with civil society. This is our opportunity to turn the words expressed at the High-Level Conferences in Berlin in 2004 and 2014 into actions that make societies safer for our Jewish communities – in fact, safer for everyone."

Identify a practical model for civil society to engage in inclusive coalition building, create a training package that supports the model, and hold youth activist workshops to promote exchange.

ODIHR will work to broaden support for the campaign by creating practical tools, both on and offline, that are easily accessible to and customized for the widest possible range of audiences across the OSCE area, to promote a human-rights based approach to ending anti-Semitism.
