


The transnational project "Living Together: European Citizenship against Racism and Xenophobia [co-financed by European Commission: Directorate-General Justice, Freedom, Security-Fundamental Rights and Citizenship EU Programme (2007-2009)-JLS/FRC/2007] works towards a major aim: the promotion of a European discourse of tolerance, based on the generation of a rationale for harmony and respect, on recognition of differences, and on building European citizenship estranged from any kind of racism and xenophobia. Promote Principles of Respect and Dialogue, Perceiving Cultural Diversity as Enriching.

In order to work towards this aim, four specific tasks were proposed:

- 1 To identify and analyze the main "social beliefs" (prejudices, stereotypes, citizens' fears) generating racist and xenophobic discourses, discriminatory actions and the legitimizing of racist attitudes in European countries.
- 2 To detect and compile a catalogue of "best practices" on tolerance and dialogue containing tolerance discourse, models, and mechanisms for harmony that are being developed in these countries with the aim of getting to know various strategies to fight against racism, xenophobia, and discrimination due to ethnic or national origin.
- **3** To prepare a *Decalogue for Citizenship, Tolerance and Dialogue* that summarizes common tenets of harmony and respect geared towards *European citizenship* in order to neutralize racist and xenophobic discourses and help various social agents.
- **4** To generate a trans-national monitoring and reaction mechanisms to fight against *new racist discourses*.
